SALE AND SUPPLY OF ALCOHOL ACT 2012

OFF-LICENCE

Sections 17 and 64, Sale and Supply of Alcohol Act 2012

Section 35 applies to the licence

PURSUANT to the Sale and Supply of Alcohol Act 2012(the Act), **SWIFT RENTALS LIMITED** (the licensee) is authorised to sell alcohol on or from the premises situated at **40 HEWLETTS ROAD, MOUNT MAUNGANUI** and known as **"BLISS BASKETS & GIFTS AND SORPRESA LUXURY GIFT BASKETS"**, to any person for consumption off the premises and to supply complimentary samples of alcohol on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, and supplied free as a sample for consumption on the premises, only on the following days and hours:

MONDAY TO SUNDAY 07:00am to 10:00pm

- 2. No alcohol is to be sold on or delivered from the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
- 3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. The Licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
- 5. A properly appointed Certificated, or Acting or Temporary, Manager must be on duty, at or nearby the point of sale, at all times when the premises are open for the sale and supply of alcohol.
- 6. The Licensee must follow the procedures set out in Regulation 14 of the Sale and Supply of alcohol Regulations 2013 to ensure that neither the purchaser nor the person to whom alcohol is delivered is a minor.
- 7. The Licensee must display on its website and/or in its catalogue on every receipt issued for alcohol sold remotely:
 - a. The licence holder's name and licence number,
 - b. The date on which the licence expires;
 - c. A legible image of the licence or a clearly identified link to such an image.

THE LICENSED PREMISES

The premises, situated at 40 HEWLETTS ROAD, MOUNT MAUNGANUI, is more precisely identified as outlined in a plan date stamped as received by the Tauranga District Licensing Committee on 28 August 2018.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force until the close of the period for which it is renewed.
